(*) All scholarships to be continued in subsequent years only for those maintaining minimum 80% class attendance in the previous year (both the semesters). It is mandatory & will not be relaxed under any circumstances.

(**)The scholarship for 2nd year onward will be continued only if the scholar secures minimum eligible marks in the Ist years (or previous year) as mentioned above in minimum eligibility marks “criteria for continuation of scholarship” column or more marks in aggregate in each of the semester examinations, which determines his/her promotion to next higher class/year. In case of non fulfilment of minimum eligible marks criteria in Ist year / subsequent years the scholarship will be cancelled for the next year. A Scholarship once cancelled shall not be renewed or restored under any circumstances.

(***) For Covid Warriors (front line staff who have rendered service in fighting the Covid Pandemic as a national duty) e.g. doctors & all medical health care professionals, police personnel; front line govt. officials or Quarantine center staff, NGO personnel who have done bonafide duties of food/help/distribution etc. a flat scholarship of Rs. 20,000/- (but not exceeding 20% of total amount payable) will be admissible in the Ist year of admission. However, if the scholar is eligible for any other category of scholarship then this amount will be adjusted against the same and only the excess amount (if any) shall be payable.
