

- 2. The following points were discussed and finalized in the meeting:
 - a) Based on the data presented on student enrollment vis-a-vis actual intake, the committee felt that there is very low admission in the branch of Civil Engineering, Mechanical Engineering and Biotechnology. The committee felt that the student intake in the above mentioned branches can be reduced to 30 seats each from existing 60 seats.
 - b) Based on the present data and statistics on the demand for computer science engineers in the job market, the committee discussed the feasibility of accommodating higher number of students considering the factors such as infrastructure, faculty availability and resource allocation. The committee felt that the student intake in the above mentioned branch can be increased to 180 seats from existing 120 seats.


